CANDIDATE INTERVIEWS FOR CITY COMMISSION POSITION #1

Mayor Brian Shepherd stated that at the City Commission meeting on February 20, 2006, four persons were selected for consideration of appointment to Commission Position #1. He stated each candidate would be given up to fifteen minutes for their presentation.

Mr. Steve Reynolds, 1309 Joyce, addressed the Commission and read his prepared statement.

Mr. Bill Kloeblen, 1770 Country Club Road #2, addressed the Commission and read his prepared statement.

Mr. Chester McCoy, 336 Simpson Road, addressed the Commission and read his prepared statement.

Mr. Bill Mason, 1661 Arizona, addressed the Commission and read his prepared statement.

After the presentations, Interim City Manager Richard Chesney distributed ballots to the Commission for selection of two candidates to respond to Commission questions.

Leon White, 1928 Jamaica Street, read a statement suggesting that Mayor Brian Shepherd make the selection for the open City Commission position.

Ladislado Hernandez, 1136 South Summit, stated that he will support the City Commission.

Interim City Manager Chesney stated, based on the Commissioners' ballots, the two candidates were Steve Reynolds and Bill Mason.

Each candidate was asked numerous questions from the Commission.

Commissioner Pershall moved to appoint Steve Reynolds to the City Commission Position #1 until the next election in April 2007.

Commissioner Fagg seconded the motion.

Motion carried 4-0.
